19 This matter having come before the Court on the Receiver's Motion for Entry of  
20 Default Judgment and the Court having reviewed the pleadings of record and Declaration  
21 submitted by the Receiver for Trend Management Group, Trend Capital, L.L.C., and the

1 Trend Group, Inc. ("Receiver"), finds that Defendant Rebecca Harter ("Defendant") was  
2 regularly served with process and failed to appear and answer the Receiver's Complaint  
3 within the period prescribed by law, that the default of Defendant was duly entered by the  
4 Clerk of this Court, that the Receiver's claim is for a sum certain, that Defendant was neither  
5 an infant nor incompetent, and that the Receiver of Trend Management Group, Trend Capital,  
6 L.L.C., and the Trend Group, Inc. is entitled to the relief requested.

7 Based upon the foregoing findings, and good cause appearing therefore;

8 IT IS ORDERED, ADJUDGED AND DECREED that the Receiver of Trend  
9 Management Group, Trend Capital, L.L.C., and the Trend Group, Inc., be awarded Judgment  
10 against Defendant Rebecca Harter in the amount of \$15,649.10 with interest at the legal rate  
11 from the date of this judgment until paid in full, and service costs in the amount of \$167.50  
12 with interest at the legal rate from the date of this judgment until paid in full.

13 IT IS FURTHER ORDERED that the Court having expressly determined under Rule  
14 54(b), A.R.C.P. that there is no just reason for delaying entry of final judgment, the Clerk is  
15 directed to enter final judgment against Defendant Rebecca Harter.
