1 IT IS FURTHER ORDERED that the Receiver shall have judgment against Richard
2 and Maureen Martinez in the amount of \$37,379.22 representing the fraudulent transfer
3 received by them from the Receivership Entities.

4 IT IS FURTHER ORDERED Receiver shall have further judgment against Defendants
5 Richard and Maureen Martinez for post-judgment interest to bear interest at the rate of 10%
6 per annum on the foregoing from the date hereof until paid, together with accruing costs and
7 attorney's fees.

8 IT IS FURTHER ORDERED that the Court having expressly determined under Rule
9 54(b), A.R.C.P. that there is no just reason for delaying entry of final judgment, the Clerk is
10 directed to enter final judgment against Defendants Richard and Maureen Martinez.
