1 1. Armando and Giselle Navas' Objection to the Receiver's March 14, 2008 Claim's  
2 Report was timely received by the Receiver on April 15, 2008.

3 2. The appeal in 1CA-CV 070546 may render the Receiver's March 14, 2008  
4 Claim's Report and/or interested parties Armando and Giselle Navases' Objection to the  
5 Receiver's March 14, 2008 Claim's Report moot.

6 3. The adjudication by this Court of any claim of Armando and Giselle Navas will  
7 be stayed and held in abeyance until appeals process in the Court of Appeals case 1CA-CV  
8 070546 is complete.

9 4. When the appeal process is complete, the parties will notify this Court of any  
10 necessary issues that need to be addressed in connection with the Navases claim.

11 5. If all proceedings in this Court in connection to the Receivership, but for the  
12 Navas' claim, are complete prior to the completion of the appeal process, this Court will  
13 retain jurisdiction over any issues in the Receivership concerning the Navases claim.

14 6. Because the Receiver has demonstrated that he has reserved enough money to  
15 pay the Navases' claim, the Parties do not believe the entire Trend claims process should be  
16 stayed pending the outcome of the Receiver's appeal.
