1 IT IS HEREBY ORDERED that the Receiver may file a supersedeas bond in the
2 Superior Court for the County of Maricopa in connection with the Receiver's appeal
3 from the "Order to Enforce Judgment Against Garnishee Trend Management Group,
4 Inc." dated June 7, 2007 arising out of the above-captioned matter. The amount of the
5 supersedeas bond is set in the amount of \$200,000.00 (two hundred thousand dollars)
6 and includes a \$500 (five hundred dollar) bond for costs on appeal that is required by
7 Rule 10, Arizona Rules of Civil Appellate Procedure. The supersedeas bond may be
8 filed in the form of a cashier's check made payable to the Clerk of the Superior Court.

10 The Clerk of the Superior Court is ordered to accept the filing of the supersedeas
11 bond as described above. Upon the filing of the supersedeas bond in the Superior
12 Court, enforcement of the Order appealed from shall be automatically stayed pursuant
13 to Rules 7(a)-(c), Arizona Rules of Civil Appellate Procedure and Rule 62, Arizona
14 Rules of Civil Procedure.
