Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

1. On November 20, 2006, this Court entered its *Order Appointing Receiver*, which appointed Peter S. Davis as Receiver of ("Receivership Order").

2. Pursuant to *Order Re: Petition No. 1* the Court approved the Receiver's compensation at the rate of \$200.00 per hour together with all reasonable costs and expenses

1 incurred relating to these services as Receiver. These services are billed by and paid to the
2 Receiver's firm, Simon Consulting, LLC.

3 3. Pursuant to this Court's Order Re: Petition No. 1, the Receiver has engaged the
4 services law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver
5 has agreed to pay the law firm compensation at agreed hourly rates for the services of the
6 firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

7 4. Pursuant to this Court's Receivership Order, the Receiver has engaged the
8 services of A & A Investigations, LLC, of Scottsdale, Arizona, and the Receiver has agreed
9 to pay A & A Investigations, LLC at agreed hourly rates for the services of the firm together
10 with all reasonable costs and expenses incurred on behalf of the Receiver.

11 5. Pursuant to the Court's *Order Re: Petition No. 2* the Receiver is authorized to
12 file this fee petition without including as exhibits the itemized of services rendered to, and
13 costs incurred or expended on behalf of, the Receivership, provided that the pay petition
14 includes a statement that anyone desiring additional information concerning the services and
15 costs to be paid under the pay petition may obtain redacted information from the Receiver by
16 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
17 written request specifying the additional information requested at least three (3) days prior to
18 the date set for hearing on the pay petition. The Court's Order Re: Petition No. 2 further
19 provides that at the time the fee petition is filed, the Receiver shall provide to the Court for in
20 camera review by the Court, the detailed statements and supporting documentation for the
21 services and costs to be paid under the pay petition.

1 6. The Receiver has submitted an itemized statement for services rendered to this
2 Receivership and for reimbursable costs incurred or paid during the period from March 1,
3 2007 through March 31, 2007. The total amount requested for payment by the Receiver is
4 \$42,021.89. The Receiver believes that this amount is reasonable and should be paid from
5 the Receivership Assets.

6 7. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
7 statement for services rendered to this Receivership and for reimbursable costs incurred or
8 paid during the period from March 1, 2007 through March 31, 2007. The total amount
9 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$20,496.62. The
10 Receiver believes that this amount is reasonable and should be paid from the Receivership
11 Assets and has therefore approved this statement for payment.

12 8. The investigations firm of A & A Investigations, LLC, has submitted an
13 itemized statement for services rendered to this Receivership and for reimbursable costs
14 incurred or paid during the period from February 1, 2007 through February 28, 2007. The
15 total amount requested for payment by the investigations firm of A & A Investigations, LLC
16 is \$5,694.00. The Receiver believes that this amount is reasonable and should be paid from
17 the Receivership Assets and has therefore approved this statement for payment.

18 WHEREFORE, the Receiver respectfully requests that the Court enter an order
19 authorizing the Receiver to pay from Receivership Assets:

20 1. The amount of \$42,021.89 to Simon Consulting, LLC for services rendered
21 and costs incurred or paid during the period March 1, 2007 through March 31, 2007;


